The Las Vegas Valley Groundwater Management Program (GMP) provides this sub-meter assistance program to help eligible well users pay for the acquisition and installation of meters on individual homes that are on wells.

Eligible well users will receive assistance through the sub-meter assistance program by the receipt of an installation incentive in an amount not to exceed \$150 upon verification of installation of the meter provided by the program.

Eligibility

Eligibility for the sub-meter assistance program is at the sole discretion of SNWA. However, to be considered for the sub-meter assistance program, the well owner must be in good standing in terms of payments of the annual groundwater management fee collected by the Southern Nevada Water Authority. Also, well owners must currently have use of one of the following well or permit types:

- Domestic well (domestic well as defined in N.R.S. 534.180)
- Community or quasi-municipal well

*Note: Well owner place of use must be listed as a legal point of use for the well through a domestic use or a permitted use by the State of Nevada, Division of Water Resources.

The well owner is eligible to receive one (1), installation incentive per qualified residence, subject to verification by SNWA. In order to receive the installation rebate, the well user will have the State of Nevada, Division of Water Resources verify the installation of the meter. Only meters provided through the Sub-Meter Assistance Program qualify for the installation rebate. Well owners must install the meter and submit an installation rebate application within one (1) year of receiving the meter.

STATEMENT OF APPLICANT

I understand that if I qualify for the installation incentive under this program, I am accepting that the State of Nevada, Division of Water Resources must verify that the meter was installed per the specification and is functioning properly. I acknowledge that SNWA is providing the installation incentive as a courtesy and is under no obligation to provide the rebate without the required verification.

I hereby certify that all information I have provided in this application is true and accurate to the best of my knowledge. Should I furnish any false information that I know to be false or should know to be false on this application, I hereby understand that such an act shall constitute cause for denial of my application. I also hereby agree to abide by the terms of the program as described above.

I acknowledge that the receipt of a meter under this program in no way implies access to a connection to municipal service.
